### Adjustment rules 2025:

1. The fuel surcharge will be adjusted on a monthly basis and will be valid for one calendar month.

2. The surcharge will be calculated based upon a one month average USD per metric tonne price for LSMGO 0,1% for the routes in kategori A to F and for LS 0,5% for the routes in categories G to K as of S&P Platts Dimensions Rotterdam [www.spglobal.com](http://www.spglobal.com), plus a delivery charge\*.

The conversion rate will be the average for the same one month period, as quoted by the Swedish National Bank\*.

3. The adjustments will take place on the 1<sup>st</sup> of each month.

4. Rosslare-Cherbourg surcharge is now based on 44% 0,1% MGO fuel and 56% 0,5% LS fuel in the adjustment rules.

\* To facilitate introduction of new BAF rates on 1<sup>st</sup> of each month, the calculation is based on the average USD per metric tonne price for LSMGO 0,1%, LS 0,5% and USD rate of exchange up to the 21<sup>st</sup> of the previous month (e.g. May based on 22<sup>nd</sup> March to 21<sup>st</sup> April).

5. As from January 1<sup>st</sup> 2025 Fuel EU Maritime biofuel compliance is included in the fuel surcharge by a share of B100 on all routes.
